# Cryptocurrency Trading

---

### CRYPTOCURRENCY COMMISSIONS (GENERAL)

**Price Taker Commission** – 0.2% of the value of the trade. Price takers are traders that either trade at market, or take a bid or offer already displayed in the market.

**Price Maker Commission** - 0.1% of the value of the trade. Price makers are traders that add a bid or offer already displayed in the market.

### CRYPTOCURRENCY - AICOIN (XAI)

**Buying XAI** – No commission.

**Selling XAI / Price Taker Commission** – 0.2% of the value of the trade. Price takers are traders that either trade at market, or take a bid already displayed in the market.

**Selling XAI / Price Maker Commission** - 0.1% of the value of the trade. Price makers are traders that add a bid already displayed in the market.

### FINANCE CHARGES

**The finance charge** is 0.082% (daily rate) for any shorted currency or leveraged trade. Financing charges associated with stock trading are handled separately.

## Stock / ETF Trading

---

### **US STOCK TRADING SERVICE FEES & INCOME**

---

**Commissions** – 0.1% on the value of the trade (\$1/\$1,000 worth of stock)

**Finance Charges** – Overnight rate of **Day 1 - 90** that a position is held: **0.023% (daily rate)**. Overnight rate of **Day 91 onwards: Fed Funds +2% (annual rate.)**

**Stock dividends** – If you hold a long position on the day a stock or stock index yields a dividend that is paid to your account minus the 30% US withholding fee. If you hold a short position on the day of a dividend yield, that is charged to your account.

### **UK AND GERMAN STOCK TRADING SERVICE : FEES & INCOME**

---

**Commissions** – 0.1% on trade value (£1/£1,000 worth of stock UK, €1/€1,000 worth of German stocks.)

**Finance Charges** – Overnight rate of **Day 1 - 90** that a position is held: **0.023% (daily rate)**. Overnight rate of **Day 91 onwards: UK stocks - Libor +2%** (annual rate) German stocks - **Euribor Funds +2%** (annual rate.)

**Stock dividends** – If you hold a long position on the day a stock or stock index yields a dividend that will be paid to your account. If you hold a short position on the day of a dividend yield, that is charged to your account.

### **HONG KONG STOCK TRADING SERVICE : FEES & INCOME**

---

**Commissions** – 0.1% on the value of the trade (HKD1/HKD1,000 worth of stock.)

**SFC Transaction Levy** - 0.0027% (on each leg of the trade)

**Stamp Duty** - 0.1% (on each leg of the trade)

**Finance Charges** – Overnight rate of **Day 1 - 90** that a position is held: **0.023% (daily rate)**. Overnight rate of **Day 91 onwards: the HKD HIBOR (overnight rate).+2% (annual rate.)**

**Stock dividends** – If you hold a long position on the day a stock or stock index yields a dividend that will be paid to your account. If you hold a short position on the day of a dividend yield, that is charged to your account.

# Cryptocurrency Liquidity Providers

---

Panxora provides a discounted fee structure for market makers that add over \$750,000 liquidity to the exchange over a 30 day period. In any 30 day period that an account adds more than \$750,000 liquidity into cryptocurrency trading, there will be a commission rebate equal to their cryptocurrency related trading commission during that period.
