

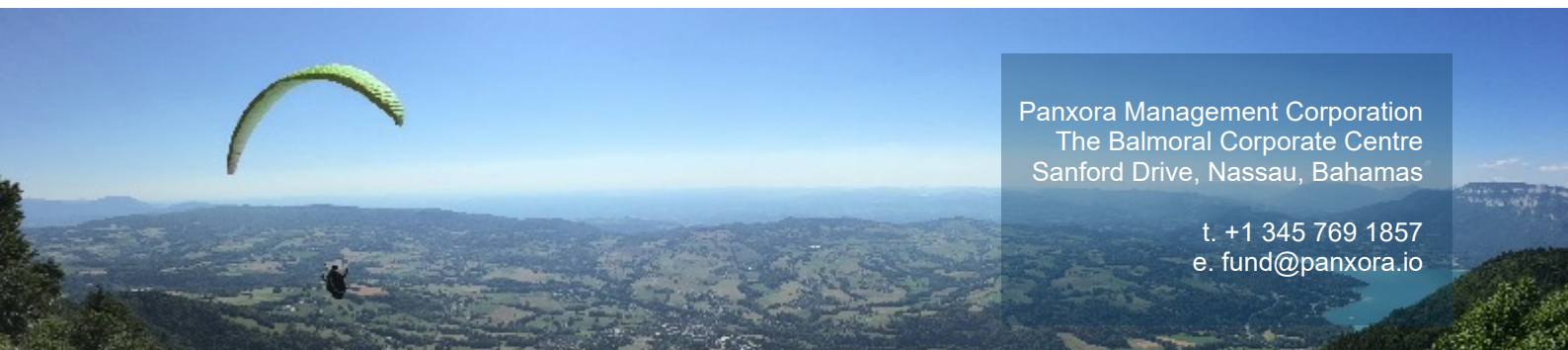
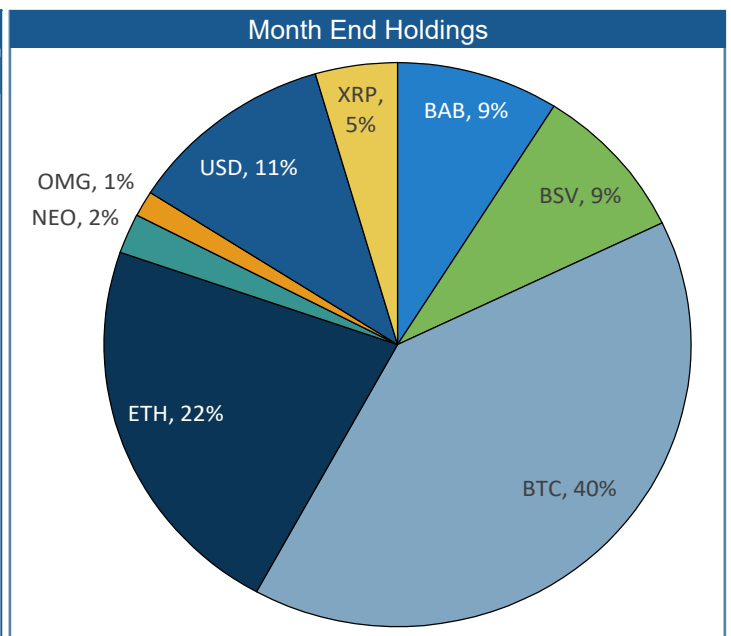
# Crypto I Hedge Fund

## FUND MANDATE

The goal of Panxora Crypto I is to outperform a buy and hold cryptocurrency strategy on a risk adjusted basis. The Fund is unleveraged, generating excess returns by only taking long positions in up to 20 of the most liquid cryptocurrencies. The trading approach is 100% systematic. Discretion is only applied to the selection of cryptocurrencies included in the trading programme based on liquidity statistics and market capitalization. The fund achieves a return delta of 40% during crypto up markets and only 27% during down markets. This 13% differential is the key factor that delivers a significantly better Sharpe Ratio compared to a buy and hold strategy.
